## Of Note CFMTA/FCAPM Monthly Memo

In the midst of the Covid-19 Pandemic, we are all struggling with how to keep going while maintaining a positive outlook for our students, our families and ourselves.

As the overarching link for music teachers from coast to coast to coast, CFMTA/FCAPM reached out to Provincial Associations to touch bases and gather information on how Canadian music teachers are faring during this difficult time. The following email from Anna Avery, president of the Yukon RMTA, eloquently sums up our unique situation:

***As we pass into these unprecedented times that we are all experiencing, we must remember that student/mentor relationships have been going on for centuries, and as we must TEMPORARILY distance our personal contact, we must adapt to how to do online lessons. No duets with our students, no touching their wrist or arm to help positioning or relaxation, and perhaps frustration with our new technical tools.***

***We are required to be deeper thinking teachers, to be able to measure and respond to anxiety from computer based perception, to think of new ways to accomplish musical gains, and have new games to play. Teaching is an art form that is always developing new ways to develop musical minds.***

***CFMTA/FCAPM is an organization that is good at putting ideas together. Sharing ideas, tips, forums used is helpful. Connection will make our isolation more bearable, and help us to realize that we are ALL in this together.***

### **FEDERAL GOVERNMENT SUPPORT RE: COVID-19**

The Federal Government has initiated the Canada Emergency Response Benefit (CERB) to help workers and businesses. Essentially, many our CFMTA/FCAPM music teachers would benefit from the CERB initiative, since we are self-employed individuals.

Some pertinent facts:

- The CERB will apply to wage earners, as well as contract workers and self-employed individuals who would not otherwise be eligible for Employment Insurance (EI).
- The portal for accessing the CERB will be available in early April.
- Canadians should begin to receive their CERB payments within 10 days of application.
- The CERB is to be paid every four weeks until October 3, 2020.
